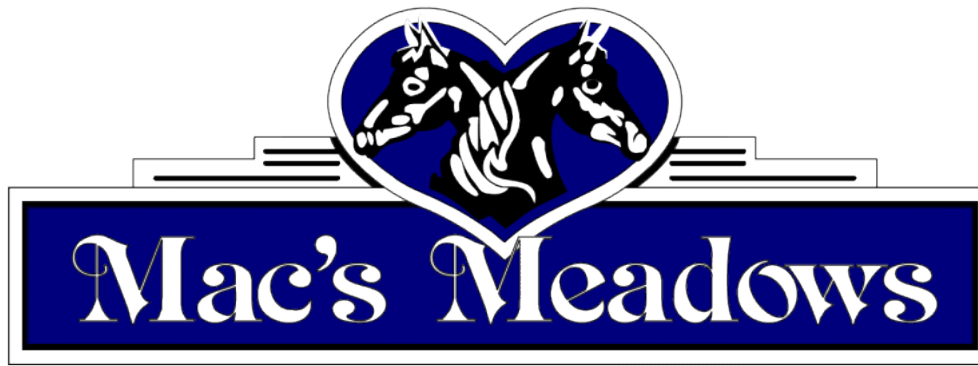

### **SERVICE AGREEMENT**

The following SERVICE AGREEMENT sets forth the terms and conditions of the services to be provided for \_\_\_\_\_, a horse or horses owned by the undersigned (herein after referred to as HORSE(S)).

These services will be performed by Mac's Meadows, John McMichael and/or Karen McMichael. These services include: feeding and watering the HORSE(S), cleaning and maintaining the stall in which the HORSES(S) is kept, turning the HORSE(S) outside in an enclosed area as necessary or requested.

FOR FURTHER CONSIDERATION IN ADDITION TO THE MONTHLY RATE, the following services are available: the HORSE(S) will be ridden and trained by either John McMichael and/or Karen McMichael (herein after **TRAINER**) on a part-time or full-time basis.

FOR A SPECIFIED HOURLY RATE, the undersigned can receive a riding lesson, while riding the HORSE(S), from either John McMichael and/or Karen McMichael.

IT IS FURTHER UNDERSTOOD AND ACKNOWLEDGED that during the time that the HORSE(S) is being trained the HORSE(S) shall be in the custody of the TRAINER. The TRAINER will exercise discretion in the training of the animal, and it is understood that each animal is unique and the TRAINER cannot guarantee the results or degree to which the HORSE(S) will be trained. Undersigned further understands that the training of a horse involves the placing of above normal stresses on the HORSE(S) both physically and mentally and that the TRAINER is in no way responsible for the results of such stress, which could potentially include injury, illness and/or loss of the HORSE(S) by death.

FOR A SPECIFIED RATE, the HORSE(S) can be transported to and from horse show, be under the general care and direction of Mac's Meadows, John McMichael and/or Karen McMichael and be shown by either John McMichael or Karen McMichael.

IT IS UNDERSTOOD AND AGREED that the undersigned will obtain and maintain any insurance upon the HORSE(S) that the undersigned deems necessary. IT IS FURTHER UNDERSTOOD that Mac's Meadows, John McMichael and/or Karen McMichael **WILL NOT AND DO NOT INSURE, EITHER BY THEMSELVES OR BY ANY COMMERCIAL CARRIER, THE LIFE OR USABILITY OF THE HORSE(S) BEING TRAINED, BOARDED AND/OR TRANSPORTED.**

**IT IS HEREBY ACKNOWLEDGED AND AGREED** that in consideration of the above services and terms as set forth herein, I, the undersigned, do agree to hold Mac' s Meadows, John McMichael, Karen McMichael, its agents, officers, members, insurers and affiliated organizations from legal liability due to the execution of the services as outlined above. I acknowledge I shall make no claims, demands, actions and causes of actions and/or litigation against Mac's Meadows, John McMichael, Karen McMichael, its agents, officers, members, insurers and affiliated organizations for any economic and/or non-economic losses due to bodily injury, death, property damage, injury to the HORSE(S) and/or any other injury to my person, my heirs and/or my agents which arise in the execution of the services as detailed above.

**THIS AGREEMENT** shall be legally binding when fully executed. This agreement was entered into in the state and county of the domicile of Mac's Meadows and will be interpreted and enforced under the laws of this State. Any disputes shall be litigated in the County of Livingston and the State of Michigan. If any clause, phrase or word is judicially determined to be in conflict with Michigan State Law, then only that clause, phrase or word shall be considered null and void.
